My brothers and sisters, we hear in our second reading from St. Paul: “Owe nothing to anyone, except to love one another...” This is a very profound verse. Do we owe anyone an apology for having hurt them? We all know how we can keep ourselves in spiritual chains by not forgiving, but here the Apostle is exhorting us to keep ourselves free of the spiritual chains that bind us when we refuse to say we’re sorry. Either (1) refrain from doing wrong to others or (2) if you do wrong to them, apologize to them from the heart.

And yet I believe there is another way we can follow Paul’s injunction to “owe nothing to anyone”. (3) We can “owe nothing to anyone” by making sure our consciences are well formed. Often in life, people will get mad at us for no good reason. There is the denial of true guilt. This is a danger all of us can fall into. Just as dangerous, however, is the mistaken embracing of *false guilt*. The only way we can avoid false guilt is by making sure our consciences are well-formed.

With the recent passing of my mother, I started reading the book, *How to Survive the Loss of a Parent* by Lois F. Akner. The author writes about a member of her bereavement group we’ll call “Mary Ann”. Mary Ann and her mother were close—too close. Mary Ann’s mother told her that she was her favorite child. Mary Ann was closer to her mother than she was to her husband and even her own children. Mary Ann and her mother would call each other a dozen times a day. When her mother went into the hospital, Mary Ann saw her every day. One Friday evening Mary Ann and her husband decided to visit some friends. Mary Ann told her mother she’d call her when she got back from the visit. When Mary Ann got back, it was very late, and she thought it best to call her mother the next day. Saturday morning, Mary Ann called her mother who proceeded to give her a tongue lashing: “I waited all evening for you to call!” Mary Ann then got mad and yelled at her mother. They both hung up on each other. During Sunday’s phone conversation, Mary Ann’s mother was cold towards her. That Monday, Mary Ann’s mother suddenly died. Mary Ann’s guilt knew no bounds.

However, Mary Ann’s guilt was *false guilt*. Objectively speaking, Mary Ann did nothing wrong to her mother. Instead of loving her daughter and equipping her to enter healthy and loving relationships with other people, Mary Ann’s mother made her daughter dependent upon her. She mothered Mary Ann out of her own needs instead of Mary Ann’s needs. Through years of the imposition of false guilt, she intruded into her daughter’s conscience and twisted it out of order so that her daughter could think something was wrong that was not truly wrong. What would St. Paul say to Mary Ann? “Dear Mary Ann, you have not failed in your obligation to love your mother. This is your mother’s issue, not yours. You do not owe her anything in this matter. Please be free.”

My brothers and sisters, if we want to live lives of true Christian charity and freedom, we must form our consciences well. We do this through a temperate use of social media, knowing the media can inculcate in us false values. We do this through the frequent celebration of the sacrament of reconciliation where we can examine ourselves and speak with a priest about what is right and wrong. We do this through developing relationships with emotionally healthy and morally upright people who are good examples for us. We do this through the regular reading of good books, and especially the reading of good catechetical material. I recommend starting with the *Catechism of Pius X* or the *Baltimore Catechism* no. 2. The sections in these catechisms on the commandments and precepts are timeless, simple, clear, and profound. They are good places to start before moving on to more complex reading. My brothers and sisters, let’s not be in debt to anyone, whether that debt is true or false! Let us live in the truth and in true love!

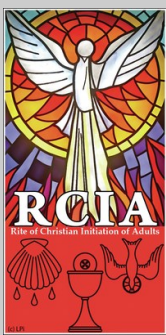

## **El Amor de los Padres en la Familia**

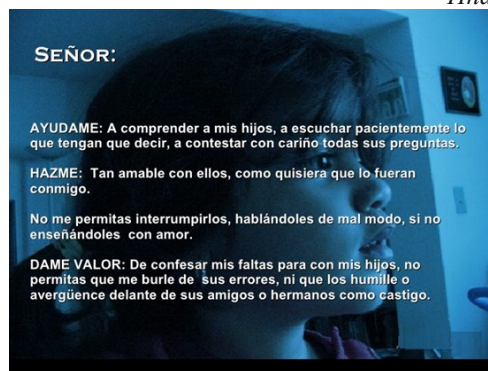
¿Realmente el papá o la mamá lo ama? Si siempre el papa dice que no tiene tiempo para el hijo o grita una respuesta a la pregunta de su hija, no está mostrando amor a esa hija o hijo. Si los hijos piden que su madre o su padre va con ellos al parque o juega con ellos en el patio, y los padres dicen que no, "Hace demasiado calor" o "Estoy cansado," o "Quizás mañana," o "Por qué ustedes no juegan juntos." Hay tantas excusas que los padres de familia tienen. Es verdad que la familia debe orar juntos, pero también debe jugar juntos, cenar juntos, trabajar juntos, pasar algún tiempo juntos para recrearse. Padres, participen en las vidas de sus hijos.

Los padres por sus acciones dan el buen (o el mal) ejemplo a sus hijos. A veces los padres de familia desean que los hijos actúen de cierta manera, pero no es cómo los padres actúan. Los padres y madres no deben dominar y controlar. Siempre los padres deben desear lo mejor para sus hijos, por eso hay que corregirlos con amor, explicándoles el por qué, y a veces tienen que disciplinarlos, y darles límites que permiten que los hijos crezcan.

Ah, pero la paciencia es algo que los padres tienen que desarrollar. Puede ser que la primera reacción a una acción mala hecha por el hijo es gritarle o pegarlo. Intenten cerrar la boca y hablarle con gentileza de cómo esa acción le hace sentir. Espera, ora y espera más con paciencia, ternura, perdón y misericordia. Siempre alaba a su hijo cuando hace las cosas bien y cuando se porta bien. Ustedes como padres necesitan compartir con los hijos los valores que son importantes. Ustedes ayudan los hijos formar sus conciencias por animarlos hacer el bien cuando comparte su juguete con otro, dice la verdad, o se queda en el patio cuando lo piden. Si no hace la cosa correcta, tiene que corregirlo y explicarle por qué su acción es inmoral para que ellos puedan aprender la diferencia entre el bien y el mal. De a poco ellos van a ver que no deben solamente pensar en sí mismos, sino en otros y lo que ellos hacen y dicen puede herir a otros.

Madres y padres, tomen tiempo con sus hijos--tiempo para gozarlos, tiempo para hacer cosas con ellos, enseñándoles hacer cosas domésticas, aprender destrezas nuevas, y saber la diferencia entre el bien y el mal. Siendo buenas guías, ayúdenles perdonar y aceptar el perdón, respetar y amar.

### Family Ministry

#### Gospel Reading Matthew 18:15-20

Jesus teaches his disciples how to settle disputes in the Church. Conflict and disagreements are a natural part of family life. Yet, within our family, we have an important opportunity to learn how to resolve disagreements fairly by treating people with love and respect.

As you gather as a family this week, discuss the procedures for resolving disputes in your family. What kinds of things produce disagreements in your family? Do children frequently request the assistance of the adults when a disagreement arises? How do the adults respond? In today's Gospel, Jesus teaches his disciples the way in which they are to handle conflict within the Christian community of the Church. Read together this Gospel, Matthew 18:15-20. Invite family members to summarize the steps that Jesus proposes for resolving conflict. How might today's Gospel inform your family's handling of disagreements? If you have time, your family might choose to role play how Jesus' teaching about conflict resolution might be applied to a disagreement that sometimes occurs in your household.



In today's Gospel, Jesus also promises that he will help those who pray to him with their needs. Pray together that each member of your family will learn to handle conflict in a Christian manner.
